The Brabant Philharmonic Orchestra, whose home base is the acoustically renowned Frits Philips Muziekcentrum in Eindhoven, the Netherlands, is *the* symphonic foundation of North Brabant. An organization of some 85 musicians, it serves up quite a broad and varied symphonic menu to this region of two-and-a-half million Brabant residents. The orchestra also accompanies opera productions (Opera Zuid) and offers a number of educational culture projects. Brabant's five main cities - Breda, Eindhoven, Helmond, 's-Hertogenbosch and Tilburg - are where the Brabant Philharmonic most often performs. In addition, each season the orchestra appears on such national stages as the Concertgebouw (Amsterdam), the Doelen (Rotterdam) and Muziekcentrum Vredenburg (Utrecht). The Brabant Philharmonic Orchestra fulfills a vital role in the international establishment thriving city-wide, in the region and beyond.
